Purpose of this Agreement

This agreement outlines the responsibilities of Axx and the Certified Delivery Partner person, ministry or church including financial and other arrangements.

Period of the Agreement

The agreement is for five years from the date of signing.

The first year of this agreement is considered a probationary period.

Axx may cancel this agreement in the first year at any time if the agreement is breached in any way.

Finances

The following principles apply:

- 1. Axx provides free of charge all training and access to the Axx online learn platform.
- 2. The Certified Delivery Partner will deliver the training free of charge if possible.
 - a. The Certified Delivery Partner is permitted to charge a small fee to cover any expenses such as:
 - i. Room hire.
 - ii. Internet connection and data charges.
 - iii. Food and accommodation if required.
- **3.** Axx does not provide any financial support to run the program.
- **4.** If the Certified Delivery Partner is found to be charging excessive fees access to the program will be immediately removed.

Axx Responsibilities

- 1. Axx does not provide lecturers to visit and teach onsite.
- **2.** Axx provides free certified training qualifications delivered online.
- **3.** These qualifications include:
 - a. Certification of Church Planting
 - b. Certification of Pastoral Ministry, and
 - c. Any additional certified qualifications added to the Light on a Thousand Hills section of the Axx website.
- **4.** Axx provides free training and associated resources to run an Axx certified qualifications.
- **5.** Axx will provide each Certified Delivery Partner with group access to the online learning platform. It contains all materials related to each course including video content and supporting resource materials as appropriate.

Certified Delivery Partner Responsibilities

- **1.** The Certified Delivery Partner will provide all equipment and facilities required to deliver the training program including access to:
 - a. Computers
 - b. Screens, TV's or projectors to view training
 - c. Internet connection
 - d. Training room with tables and chairs as required
- **2.** To complete all Certified Delivery Partner training provided by Axx
- **3.** To follow all instructions given by Axx in relations to the training programs.
- **4.** No access or logins are to be given to other parties or persons that don't form part of the Certified Delivery Partner program.
- **5.** Axx resources must not be given or sold to any other person, church or ministry without Axx permission.
- 6. Agree to abide by the Axx Certified Delivery Partner Code of Conduct.

Ownership of Courses and Training Resources = Intellectual Property

1. Axx owns the copyright to all material given to the Certified Delivery Partner. The Certified Delivery Partner may not use any Axx copyrighted material in any way outside the rules of this agreement unless otherwise authorised in writing by an authorised representative of Axx.

Problems and Issues

If any issue, problem, or dispute arises, the Certified Delivery Partner must contact Axx immediately.

Circumstances by which this agreement may be cancelled or amended

The Certified Delivery Partner fails to follow any of the conditions found in this agreement.
